The National Center for Civil and Human Rights invites students and community groups to attend a matinee performance of "Courageous Steps: Bridging the Divide for Equality!"

Written by acclaimed playwright and director Nikki Toombs, the show uses dialogue, music, and dance to debate equity in education and the impact of Brown v. Board of Education. The show follows several students grappling with the effects of Brown v. Board of Education today. During the performance, guests will be transported back to 1954, when civil rights lawyer and future Supreme Court Justice Thurgood Marshall and his team of lawyers prepared to argue Brown before the Court. They also meet a student preparing to be the first Black student to integrate her school and hear stories about the trials and triumphs of integration. At the show's end, students will have the opportunity to talk to the creative team and cast about the show.
